Please answer any FOUR (2) questions, each answer a minimum (500) words. You should draw on the texts for evidence and source to bolster your argument please use the following key points as your guide in writing your paper. You should be able to identify the following:

The reader responses should address some of these specific questions:

1. How does the author engage the idea of history, politics, and identity?

2. What was the general argument or point the author or editor made?

3. What major premises, themes, and concepts of culture or race, did the author employ?

4. What evidence did the author use? (i.e. scientific, ethnographic, personal experience)

5. Who was the audience, why was that audience chosen, and how was it received?.

Finally All exams and papers are evaluated in three key areas: content, grammar, and logic. Content is the most important of the three areas (a student may fail an exam or paper for lack of content, for example, even with good grammar and logic) but one cannot attain a grade of C or higher without at least marginally competent grammar and logic. To attain a grade of A an exam/quiz/essay must attain a superior rating in all three areas. In other words, it must rank as excellent on all three counts, free of grammatical mistakes, with a seamless logical flow from one idea to the next, and with some original interpretation. B+ is given for an above-average analysis which shows some level of excellence in content and logic with very good or excellent grammar, but has some minor flaws in grammar and logic. A grade of B is achieved by above average analysis in content with competent grammar and logic.

## **QUESTIONS:**

A. As the readings and lectures suggest, there was a differing of ideas, strategies and implementations between Booker T.
