Strengths and Areas of Interest

I believe that three of my strengths in instructional design are learner and context, instructional objectives, and evaluation instruments. Morrison, Ross, Kalman, and Kemp (2013) explain that knowing about your students gives a valuable basis for designing instruction. I believe that I am able to identify the needs and characteristics of a learner. Morrison, Ross, Kalman, and Kemp (2013) state that objectives offer a means for a designer to develop appropriate instruction. I believe that I am able to use my knowledge of learner and context to develop objectives based on the learners' needs. I also feel that I am able to determine the appropriate evaluation tools to use in order to measure whether an individual was able to meet the learning objectives or to measure the success of a program. Two areas of instructional design that I would like to learn more about are ongoing processes and technology based learning. I believe that these are two areas where I can grow as an educator and an instructional designer.
